

APPLICATION PROCESS

Applications will be accepted between Monday August 15, 2016 and Monday September 19, 2016. Applicants must apply electronically via the Attorney General's Office Employment and Recruitment Portal by visiting www.mass.gov/ago/fellowship.

In addition to a completed application, applicants must submit the following:

1. Resume;
2. Law school transcript;
3. A one page essay explaining both the reason(s) for your commitment to public interest law and your interest in the work of the Attorney General's Office.

Applicants will be asked to upload these documents as part of the application process and to indicate their interest in the Boston or Springfield office.

Writing sample and OFFICIAL law school transcript to be provided at time of interview.

Selected candidates will be invited for interviews in October/November 2016. Offers will be extended in December 2016.

We will gladly assist applicants who are unable to complete an application on-line or who are in need of an accommodation during the application process.

ABOUT THE PROGRAM

The Fellowship Program offers entry-level attorneys the unique opportunity to engage in the practice of law and policy in the largest public sector legal office in the Commonwealth.

The Attorney General's Office serves the public through its six core bureaus: Criminal, Energy and Environment, Executive, Government, Health Care and Fair Competition, and Public Protection and Advocacy. Selected fellows will be able to explore and gain experience in a variety of practice areas over the course of the two-year fellowship. Fellows in Boston generally complete three rotations through different bureaus while fellows in Springfield generally complete two rotations; one criminal and one civil.

Fellows receive training and supervision from experienced attorneys to enhance proficiency and develop skills while in the program. Through the Fellowship Program, new attorneys will launch their legal careers by enriching their legal experience, broadening their exposure to the public sector, and assuming substantial individual responsibility for their work.

Fellowship Program candidates will be selected on the basis of several factors, including:

- Academic and intellectual ability;
- Knowledge, experience, and ability in a number of legal skills areas such as research, writing, advocacy, trial preparation, discovery, investigation, negotiation, etc.;
- Legal, professional, or personal experience related to the mission of the Attorney General's Office;
- Demonstrated engagement and leadership in school and/or community activities;
- Law journal participation or other experience in writing/editing;
- Flexibility and interest in a variety of legal subject areas.

The successful candidate will be able to demonstrate a commitment to public interest law and a connection to the people and communities we serve.

ELIGIBLE CANDIDATES

The Attorney General's Office seeks applications for its Fellowship Program from:

- Third-year day or fourth-year evening law students scheduled to graduate in 2017; and
- Current full-time judicial law clerks who received their J.D. prior to 2017 and who do not yet have experience as a practicing attorney.

The Fellowship Program begins in September 2017. All individuals invited to participate must commit to a two-year term and must take the bar exam in Massachusetts no later than July 2017. The salary will be \$60,000 per year. Fellows will have the opportunity during their final rotation to seek continued employment with the Attorney General's Office.
