# FROM THE CHAIR AND EXECUTIVE DIRECTOR

Welcome to the 2015 Health Care Cost Trends Hearing. This is the Health Policy Commission's third year hosting the Hearing in collaboration with the Office of the Attorney General and Center for Health Information and Analysis. Thank you for participating in this unique public examination into the Commonwealth's health care system and costs.

The HPC's mission is to advance a more transparent, accountable, and innovative health care system through independent policy leadership and programs. Our goal is better health and better care at a lower cost across the Commonwealth. As such, we view the Cost Trends Hearing as an important opportunity to engage in an informed dialogue on spending trends, market dynamics, and policy developments that impact the performance of our health care system.

Massachusetts is a national leader in providing high-quality health care for its residents. However, health care costs continue to rise, and directly impact the budgets of government, businesses, families, and individuals across the Commonwealth. To address these growing costs, Massachusetts enacted Chapter 224 of the Acts of 2012, which includes a host of health care cost containment mechanisms, including the establishment of the Health Policy Commission and a statewide benchmark for the rate of total health care spending.

In September 2015, the Center for Health Information and Analysis reported that Massachusetts exceeded the benchmark in 2014, with health care cost growing at 4.8%, well over the 3.6% target. This year's hearing will examine the challenges the Commonwealth faced in meeting this target, asking Massachusetts health care leaders and key stakeholders to testify, under oath, on their organizations' efforts to reach this statewide goal. In addition to the in-person testimony you will hear during the next two days, over 60 health care organizations also submitted written testimony. Throughout the hearing, Massachusetts provider organizations, health plans, employers, consumers, and national experts will testify about our transforming health care delivery and payment system. We will explore factors that contribute to cost growth, and strategies to contain costs while improving patient care. With the information gathered and honest dialogue, over the next two days, we can work towards higher quality health care that is affordable and accessible across the Commonwealth. ## EXPERT SPEAKERS



### **Dr. Amitabh Chandra**

Amitabh Chandra is the Malcolm Weiner Professor of Public Policy and Director of Health Policy Research at the Harvard Kennedy School of Government. He is a member of the Congressional Budget Office's (CBO) Panel of Health Advisors, and is a Research Associate at the IZA Institute in Bonn, Germany and at the National Bureau of Economic Research (NBER). His research focuses on innovation and cost-growth in healthcare, medical malpractice, and racial disparities in healthcare. His research has been

supported by the National Institute of Aging, the National Institute of Child Health and Development, the Robert Wood Johnson Foundation, and has been published in the American Economic Review, the Journal of Political Economy, the New England Journal of Medicine, the Journal of the American Medical Association, and Health Affairs. He is an editor of the Review of Economics and Statistics, a former editor of the Journal of Human Resources, and serves on the editorial boards of Economics Letters and the American Economic Journal.



### **Dr. Leemore Dafny**

Leemore Dafny is a Professor of Strategy and the Herman Smith Research Professor in Hospital and Health Services at the Kellogg School of Management. Her research examines competitive interactions among payers and providers of healthcare services, and the intersection of industry and public policy. Dafny is a graduate of Harvard College and earned a PhD in economics from the Massachusetts Institute of Technology. She is a Research Associate of the National Bureau of Economic Research, Editor of The International

Journal of Health Economics and Management, and a Board Member of the American Society of Health Economists and the Health Care Cost Institute. In 2012-2013, Dafny served Deputy Director for Healthcare and Antitrust in the Bureau of Economics at the Federal Trade Commission in Washington, DC. She is a current member of the Panel of Health Advisers for the Congressional Budget Office. During Fall 2015, Dafny is a Visiting Professor at Harvard Business School.

# MEASURING AGAINST THE HEALTH CARE COST GROWTH BENCHMARK

Massachusetts residents have access to innovative and high-quality health care. This care, however, comes at a cost. The Commonwealth is among the states with the highest health care spending in the United States. The rapid rate of growth in health care spending has contributed to a crowding-out effect for households, businesses, and government, reducing resources available to spend on other priorities.

Chapter 224 of the Acts of 2012, a comprehensive health care cost containment law, seeks to bring health care spending growth in line with growth in the state's overall economy. To measure progress, Ch. 224 established the health care cost growth benchmark, a statewide target for the rate of growth in total health care expenditures (THCE).

## What is the Total Health Care Expenditures measure?

Total health care expenditures (THCE) is a measure of state health care spending by private and public payers, such as Medicare and the state Office of Medicaid, MassHealth. THCE includes three components:

- All medical expenses paid to providers by public and commercial payers,
- All patient cost-sharing amounts (for example, deductibles and co-payments),
- The net cost of private insurance (for example, administrative expenses and operating margins for commercial payers)

THCE is calculated on a per capita basis to control for increases in health care spending due to population growth and includes spending by both public and private payers. THCE is measured annually by the Center for Health Information and Analysis (CHIA). This measure is then compared to the "benchmark" or the growth in the state's economy.

## What is the benchmark?

Each year, the Health Policy Commission sets the benchmark for the Commonwealth. For 2013-2015, the benchmark was set at 3.6%, or the equivalent of the gross domestic state product.

For 2013, the first year in which the Commonwealth was measured against the benchmark, health care costs grew at 2.4%, 1.2% less than the benchmark.

In 2014, the Commonwealth's THCE exceeded the benchmark, with 4.8% growth. CHIA hypothesizes that several factors contributed to the Commonwealth surpassing the benchmark in 2014, including increased spending due to expanded MassHealth enrollment and prescription drug costs.

### SUMMARY


**2013:** THCE was \$50.5 billion or \$7,641 per capita.

- 2.4% increase from 2012.
- 1.2 percentage points below the benchmark.

**2014:** THCE was \$54 billion or \$8,010 per capita.

- 4.8% increase from 2013.
- 1.2 percentage points above the benchmark.

### Other Key Findings

- Spending for MassHealth increased by \$2.4 billion (+19%), while enrollment increased by 23%.
- Total medical expenses (TME) among commercial payers grew by 2.9% in 2014, compared to a 1.2% in 2013.
- Member cost-sharing rose by 4.9% in 2014. Individual purchasers and small group members continued to pay the most out of pocket.

### WHAT'S NEXT

Along with data from CHIA's annual report on the performance of the Massachusetts health care system, insights from the 2015 Health Care Cost Trends Hearing inform the Health Policy Commission's 2015 Cost Trends Report. The Cost Trends Report presents an overview of healthcare spending and delivery in Massachusetts, opportunities to improve quality and efficiency, and progress in key areas and contains recommendations for strategies to increase quality and efficiency in the Commonwealth. Findings from the report will be presented publicly in December.






