The July 27 & 28, 2016 Massachusetts Bar Examination will be administered at **WESTERN NEW ENGLAND UNIVERSITY SCHOOL OF LAW**, 1215 Wilbraham Road, Springfield, MA. A very limited number of seats will be available at this location. To be eligible to sit in Springfield, applicants must take both the Multistate Bar Exam (MBE) and the Essay examination in Massachusetts. Applicants qualified (under Supreme Judicial Court Rule 3:01, section 3) who wish to take July 2016 Massachusetts Bar Examination in SPRINGFIELD must do the following:

*This form must be completed and received by **May 13, 2016** at the **Board of Bar Examiners, Edward W. Brooke Courthouse, 24 New Chardon St. 1st floor, Boston, MA 02114.** **Space at the test site is limited, and requests will be granted on a first come, first served basis.** Therefore, this form must be completed and returned promptly.*

**IF YOU FILE THIS FORM WITH YOUR BAR APPLICATION,  
YOU WILL NOT BE ALLOWED TO SIT IN SPRINGFIELD.**

All applicants not assigned to Springfield must take the examination in Boston. Once assigned to Springfield, seating **cannot be changed** to Boston. **PLEASE MAKE SURE YOU NEED TO SIT IN SPRINGFIELD, AS YOU MAY BE TAKING A SEAT FROM AN APPLICANT WHO DOES NEED TO SIT IN SPRINGFIELD.**
