Notes:

- The column titled "OWNERSHIP" means who owns or is responsible for the landfill. It does not mean who conducted the closure of the landfill.
- The "START-FINISH" column refers to the dates when G&S with contaminated soils started and finished. The finish date is not when the final cover was completed or when the closure certification was issued.
- The "COMMENTS" column's reference to "COMPLETED" means that the acceptance of contaminated soil has been completed. It does not mean the landfill has completed closure.
