

FINAL DECISION

I have reviewed the Joint Motion to Approve Settlement and the Settlement Agreement signed by the petitioners' representatives Rachel Calabro, President of the Blackstone River Coalition on April 29, 2015, Margaret Van Deusen, Esq., for the Twelve Citizens Group on April 24, 2015, Donna Williams, President of the Blackstone Headwaters Coalition on April 29, 2015, JoAnne Holahan, President of the Blackstone River Watershed Association on April 24, 2015, by Daniel J. Morgado for the Town of Shrewsbury on May 14, 2015, and by Lee Dillard Adams, Regional Director for the Department on April 21, 2015. The Department issues this Final Decision approving and incorporating the Settlement Agreement and modified Water Management Act Permit (Permit #9P4-2-12-271.01). Pursuant to the Settlement Agreement, the Central Regional Office shall issue the modified Water Management Act Permit.

Under the terms of 310 CMR 1.01(8)(c), these proceedings are dismissed with the parties waiving whatever rights they may have to further administrative review before the Department as well as appeal to court.
