

### **Revised Notice: Vibrio Management Public Hearings and Public Comment Period**

Under the provisions of M.G.L. c. 30A and pursuant to the authority found at M.G.L. c. 130 § 17A, 52, 81 and 82, the Division of Marine Fisheries and the Marine Fisheries Advisory Commission have scheduled two public hearings and a public comment period to accept comment on draft regulations to amend the state's seasonal Vibrio management regulations at 322 CMR 16.05. These proposed amendments ensure that state regulations conform to the federally mandated Vibrio Management Plan and where possible meet requests presented by the commercial oyster industry.

#### **1. Vibrio Management (322 CMR 16.05)**

- a. Add, amend and delete existing definitions;
- b. Further clarify existing icing, shading, *Vp* logbook, and transport of market bound oyster requirements;
- c. Establish new time of icing requirements;
- d. Establish alternative methods, at the request of industry, for aquaculturists to tag re-submerged oysters; and
- e. Simplify and consolidate existing regulations governing off-site culling, oyster processing activities by aquaculturists, and the re-submergence of oysters subject to these activities.
