Injury Deaths to Massachusetts Youth & Young Adults Ages 15-24 Years

Injuries are the leading cause of death in Massachusetts for youth and young adults ages 15-24 years. In 2006, there were **325** injury deaths to persons ages 15-24, a rate of **36.3** deaths for every 100,000 youth. Transportation related injuries were the leading cause of death for this age group, followed by poisonings.
