Board Business:

At approximately 10:05 a.m., a quorum was present. Chairman Wood called the meeting of the CRRB to order.

Approval of March 25, 2015 CRRB Meeting Open Session Minutes:

After reviewing the open meeting minutes from the March 25, 2015 board meeting, William Shay suggested two edits. Robert Harnais made a motion to accept the minutes with the edits. Les Gosule seconded the motion. The motion passed 9-0, with Linda Holt and Chairman Wood abstaining from voting.

Executive Session:

At this point in the meeting, Chairman Wood indicated that the Board would be entering into Executive Session to review CORI complaints whose subject matter is protected pursuant to G.L. c.30A, § 21(a)(7), and G.L. c. 6, §172. The Board would not reconvene in open session. A motion was made by Thomas Capasso and seconded by Rhiana Kohl. A roll-call vote was taken and the motion passed 10-0 with Chairman Wood abstaining from voting. The Board entered executive session at approximately 10:15 a.m.

At the end of all discussion, Chairman Wood indicated that the Board should exit Executive Session. Robert Harnais made a motion to exit Executive Session; Michael Callahan seconded the motion. A roll call vote was taken, and the motion passed unanimously 11-0. Robert Harnais then made a motion to adjourn. Deborah Rebeiro seconded the motion.
