Abstract

This report provides a statistical description of the 14,676 offenders committed by the courts to Massachusetts county facilities (jails or houses of correction) during 1991. The report presents information on institution committed to, court committed from, month of commitment, offense, sentence length, sentence type, age, sex, race, marital status, education, place of birth and residence.

Some highlights of the statistics presented in this report are:

- In 1991 there were 14,676 commitments to county facilities. This represents an increase of 7 percent over the 13,721 commitments in 1990.
- In terms of general categories of offenses, 13 percent were committed for offenses against the person, 2 percent for sex offenses, 27 percent for property offenses, 14 percent for drug offenses, 17 percent for Operating Under the Influence of alcohol (O.U.I.), and 27 percent for all other offenses.
- The most common offenses for which offenders were committed were O.U.I. (17 percent), motor vehicle violations (15 percent), and burglary (9 percent).
- The median sentence length was four months. Eleven percent were committed in lieu of payment of a fine. One percent were serving weekend sentences.
- The median age of offenders committed to county facilities was 27 years.
- Sixty-eight percent of the offenders were Caucasian, 17 percent were African American, 14 percent were Hispanic, and one percent were other races.
- The median educational level was 12th grade.
- Sixty-one percent of the offenders were single, 12 percent were married and 11 percent were separated, divorced or widowed.
- Sixty-nine percent were born in Massachusetts, 17 percent were born in other states, 9 percent were born in U.S. territories, and 5 percent were foreign-born.

Introduction

This report provides a statistical description of offenders committed to Massachusetts county facilities (jails and houses of correction) during 1991. Included in this report is information about the county facilities and their operating expenditures. Offenders are described in terms of commitment institution, month of commitment, committing court, offense, sentence length, sentence type (weekend and jail sentences), sex, age, race, marital status, education, place of birth, and residence. Trends in court commitments to the county correctional system over the past decade are also presented. The tables were derived from information submitted by each county facility to the Operations Research Unit of the Research Division in the Department of Correction and were produced on the DOC's VAX Computer System.

When referring to the statistical tables, the reader should note the following: (1) the total population is sub-divided by commitment institution, (2) the left number in each cell represents the total number of offenders committed to a particular institution who fall into the corresponding category in that row of the table; and (3) the right number in each cell (the number contained in parentheses) is the percentage of the number of individuals in the category to the total number of individuals from that institution (column percents). In the narrative, percentages reflect only those cases where data were available. Cases with missing data were excluded. For example, on pages thirteen and fourteen, Month of Commitment is presented and the following types of information can be obtained:

- (1) The total number of offenders is broken down by commitment institution, and these are labeled and presented horizontally across the top of the table;
- (2) The specific months are labeled and presented vertically;
- (3) Of the 14,676 offenders committed during 1991, 2,556 were committed to the Middlesex County facility;
- (4) Of the 2,556 offenders committed to Middlesex County, ten percent (N=260) were committed in January.

County Facilities in Massachusetts

There are fourteen counties in Massachusetts. All counties except for Nantucket County have at least one county correctional facility administered by the county sheriff. These facilities usually contain a jail, for pre-trial detainees, and a house of correction, for sentenced inmates. The location and administrators of all facilities are shown in Appendix I. Suffolk County has a separate facility for its jail (Nashua Street) and its house of correction (South Bay). The South Bay House of Correction is administered by the Penal Commissioner of Boston. Middlesex County has two facilities, a combined jail and house of correction in Billerica and a jail in Cambridge. Four counties have specialized facilities for sentenced offenders: Essex County has the Correctional Alternative Center (CAC) in Lawrence; Hampden County has the Western Massachusetts Correctional Alcohol Center (WMCAC) facility in Springfield; Bristol County has the Eastern Massachusetts Correctional Alcohol Center (EMCAC); and Norfolk County has the Braintree Alternative Center. Individuals are not committed directly to these four facilities, but can be transferred from a house of correction or state correctional facility.


The operating expenditures for each county facility, for the fiscal year ending June 30, 1991, are shown in Appendix II. These include expenses for salaries, food, utilities and other expenses.

The population in county correctional facilities for the period January 1, 1991 to December 31, 1991 is shown in Appendix III. This includes the average daily population (ADP), beginning and ending population, design capacity, and average daily population divided by design capacity, which is a an indicator of facility utilization.

**Commitments to County Correctional Facilities,
1981 to 1991**

During 1991 there were 14,676 commitments to county facilities. This is a 7 percent increase from the 13,721 commitments in 1990, and a 135 percent increase from the 6,246 commitments in 1981. Commitments to county facilities for the last eleven years are shown in Figure 1.

The largest increase in commitments came between 1981 and 1982 when there was an increase of 36 percent or 2,254 commitments. Much of this increase was due to O.U.I. offenders. Commitments for O.U.I. increased from 295 in 1981 to 1305 in 1982, an increase of 1,010.

Table 1 shows selected characteristics of offenders committed to the county correctional system during the six year period 1986 to 1991. During this six year period, the number of commitments increased by 40 percent or 4,160 from 10,516 in 1986 to 14,676 in 1991. With the exception of Barnstable County, Dukes County, Plymouth County, Suffolk County, and Worcester County, all county facilities experienced increases in commitments from 1986 to 1991.

The offenses for which individuals were committed changed over the last six years. Between 1986 and 1991, increases occurred for all offense categories except OUI, which showed a decrease of 10 percent (N=251). During the period, commitments for drug offenses increased by 121 percent (N=1,121); commitments for person offenses increased 72 percent (N=811); commitments for motor-vehicle offenses increased by 62 percent (N=842); commitments for other offenses increased by 39 percent (N=493); commitments for property offenses increased by 38 percent (N=1104); and commitments for sex offenses increased by 18 percent (N=40).

The distribution of sentence length shifted upward over the past six years. In 1986, 41 percent of commitments had a sentence of one month or less (including fines); and in 1991, 30 percent of all commitments had a sentence of one month or less. In 1986, 36 percent of all commitments had a sentence of six months or more; and in 1991, 48 percent of all commitments had a sentence of six months or more.

The age distribution of county commitments shifted upward over the last six years. In 1986, 41 percent of the commitments were 24 years or younger and 59 percent were 25 years or older. In 1991, 34 percent of the commitments were 24 years or younger and 66 percent were 25 years or older.

A Description of 1991 Commitments

In this section the 14,676 offenders committed to county facilities during 1991 will be described in more detail. Characteristics of the present offense will be noted followed by a summary of personal background characteristics of the county offender population. Information for each institution for these variables can be found in the following tables.

Present Offense Characteristics

Commitment Institution. The number of commitments ranges from a low of 39 in Dukes County to a high of 2,556 in Middlesex County. Seven counties received more than 1,000 commitments in 1990: Middlesex (N=2,556), Worcester (N=2,157), Hampden (N=1,772), Essex (N=1,741), Bristol (N=1,486), Suffolk (N=1,435), and Norfolk (N=1,136). These seven counties accounted for 84 percent of all county commitments in 1991.

Committing Court. Most offenders committed to county facilities are sentenced by the lower courts in the county to which they are committed. Ninety-six percent were from lower courts and 4 percent were from superior courts.

Present Offense. Most offenders committed to county facilities were sentenced for non-violent offenses (85 percent); 15 percent were committed for violent offenses, those against the person or sex offenses.

Of the 15% committed for violent offenses, thirteen percent were for offenses against the

person. Most of these were for unarmed assault (assault or assault and battery) (N=1029) or armed assault (assault and battery with a dangerous weapon or assault with a dangerous weapon) (N=739). There were 33 commitments for vehicular homicide.

Two percent of the violent commitments were for sex offenses including 37 for rape, 176 for assault with intent to rape (which includes indecent assault on a mentally retarded person), and 56 for other sex offenses (e.g., unnatural acts, Incest, lewdness, indecent exposure and sexual misconduct). Of the 213 commitments for rape and sexual assault, 135 involved minors as victims and 78 involved adults as victims.

Twenty-seven percent of the non-violent commitments were for property offenses. The most common property offenses were: burglary (N=1,377), larceny (N=1,004), receiving stolen goods (N=530), Stealing (N=308), Property Injuries (N=236), and Vehicle Theft (N=162).

Fourteen percent of the non-violent commitments were for drug offenses. Eighty-nine percent of these were for violation of the Controlled Substance Act with Class A, Class B, or Class D substance (N=1,817).

Forty-four percent of all non-violent commitments were for offenses in the "other" offense category. Most of these commitments were for O.U.I. (N=2,436) and other motor vehicle violations (N=2,212). Other common offenses in this category were disturbing the peace (N=380), weapons (N=243), and contempt (N=160).

Sentence. The median sentence length for 1991 commitments was six months. In general, offenders sentenced for less than two months will serve their entire sentence, and offenders sentenced for two months or more will be eligible for parole after half their sentence is served. Eleven percent of the commitments (N=1,554) were in lieu of payment of a fine. County sentences range

up to two and one-half years, but in a small number of cases, offenders can serve consecutive sentences of two and one half years or less, such that the total length of sentence will be more than two and one half years.

Most offenders are sentenced to houses of correction, but some offenders are committed to jails. In 1991, there were 20 jail commitments (less than one percent of all commitments).

Some sentences are served only on weekends, less than one percent of all commitments were weekend sentences (N=62). Weekend sentences were used most extensively in Berkshire and Franklin countys where 2 percent of all commitments were served on weekends.

Personal Background Characteristics

Age. The age of offenders ranged from 17 years to 75 years. The median age was 27 years. There were 2,013 offenders (14 percent) age 20 years or younger and 94 (one percent) age 60 and over.

Sex. Of the 14,676 commitments to county facilities, there were 289 females and 14,387 males. Most females that received a county sentence were sent to MCI-Framingham, the state correctional facility for female offenders.

Race/Ethnicity. The majority of offenders were caucasian (67 percent). Seventeen percent were African American and 14 percent were Hispanic. There were 196 individuals (one percent) in other racial groups. Suffolk County house of correction was the only facility where the majority of commitments were not white: (52 percent African American, 32 percent caucasian, 14 percent Hispanic, and 2 percent "other").

Marital Status. Most offenders were single (72 percent). Fourteen percent were married at the time of commitment and 13 percent were separated, divorced or widowed.

Education. The median educational level was 12th grade. Eight percent had only a grade school education (first through eighth grade), 40 percent completed some high school and 43 percent were at least high school graduates. Seven percent had at least some college education and 1 percent reported having a college degree.

Place of Birth. Sixty-nine percent of all county commitments were born in Massachusetts, 18 percent were born in other states, 9 percent were born in U.S. territories and 5 percent were foreign-born. Bristol county had the highest proportion of foreign-born offenders (9 percent); Barnstable County had the highest proportion born in other states (27 percent); Hampden County had the highest proportion of offenders born in U.S. territories (25 percent); and Berkshire County had the highest proportion born in the same county as the facility (65 percent).

Residence. As reported by the county facilities, all but 404 offenders committed to county facilities were residing in Massachusetts at the time of commitment. In most cases, the offenders were residing in the same county as the facility to which they were committed. Hampden County had the highest proportion of county residents (93 percent), and Norfolk County had the lowest proportion of county residents (56 percent).
