Abstract

This report is a statistical description of the 1,234 individuals committed by the courts to a term of incarceration in the Massachusetts Department of Correction during the year 1980. The tables in this report contain information on the nature of present offense, personal background characteristics and prior criminal history of these individuals. Some highlights of the statistics presented in this report are:

- There were 528 commitments to Walpole, 470 commitments to Concord and 236 commitments to Framingham.
- The median minimum sentence for Walpole commitments is six years; the median maximum sentence for Concord commitments is ten years; and the median maximum sentence for Framingham commitments is less than one year.
- Offenses against the person accounted for the majority of the commitments. Armed robbery accounted for a quarter of the commitments alone.
- The median age at commitment was 24 years, Walpole commitments tended to be older, Concord commitments tended to be the youngest.
- Two-thirds of the commitment population are whites; almost two-thirds are single; one in six has been in the military; almost a third come from the Boston area; most have limited work experience concentrated in the area of manual labor; the median educational level is tenth grade; and almost half of the population have prior drug use.
- Forty percent of the commitment population is serving their first incarceration of any type. The median age of first court appearance is seventeen years.

Introduction

This report is a statistical description of individuals committed by the court to the Massachusetts Department of Correction during 1980. The tables in this report contain information on the nature of the present offense, personal background characteristics and criminal history of admissions from the courts to MCI-Walpole, MCI-Concord and MCI-Framingham. These tables were derived from the Correction and Parole Management Information System (CAPMIS) and were produced on the Massachusetts State College Computer Network (MSCCN).

This report includes all new court commitments as well as those who began serving a new sentence during the year. If an individual was admitted to the Department twice during 1980, they are counted as two separate court commitments. Several categories of offenders are not included in this report: those who began serving "B" and "C" sentences during 1980 (sentences received for crimes committed on parole) and those who were sentenced during 1980 but were still in a House of Correction awaiting placement in a DOC facility on January 1, 1981; there were 131 such individuals awaiting placement on January 1, 1981.


The following information is helpful in reading the tables in this report. Each table is divided according to committing institution. The top number in each cell represents the number of individuals who fall into the corresponding category in the table. The bottom number in each cell appears in parentheses and represents the percentage of the number of individuals in a particular category to the total number of commitments from that institution (column percents).

A Description of 1980 Commitments

There were 1,234 commitments during 1980, a nine percent increase from the previous year. Figure 1 shows changes in the number of commitments from 1970 to 1980. This graph indicates the cyclical nature of commitments to the DOC and shows that we are presently in an upward cycle of commitments. When considering commitments to each institution (Walpole, Concord and Framingham) there is a consistent, long-term trend toward increasing commitments only at Framingham. From 1973 to 1980 there is a clear pattern of increases in court commitments to that institution.

Nature of Present Offense

Individuals can be committed to one of three institutions: MCI-Walpole, MCI-Concord and MCI-Framingham. This report describes individuals committed to each of these institutions as well as the total population of court commitments to the Department. In 1980, 43 percent of all commitments were to Walpole, 38 percent to Concord and 19 percent to Framingham.

Court Of Commitment. Over 80 percent of the individuals committed to the Department are committed by Superior Courts. Suffolk Superior Court accounts for 23 percent of the commitments. All Walpole commitments come from Superior Courts and almost all of the Concord commitments come from Superior Courts. A very different pattern is evident for Framingham commitments. Over three-quarters of the women entering Framingham are from municipal courts and district courts. Municipal courts are lower courts of Suffolk County, district courts are lower courts of all other counties.

Jail Credits. Jail credits measure that amount of time spent incarcerated before a sentence is imposed. A large number of jail credits is usually indicative of a serious crime or a low income offender. For example, almost 80 percent of all Framingham commitments come to the department with no days of jail credits. The median number of jail credits for all commitments during 1980 was 13.

Minimum Sentence. Only those individuals who receive a state prison sentence (Walpole commitments and Framingham prison commitments) receive a minimum sentence. Generally minimum prison sentences must be for more than two years but in some cases can be for one year (assaulting correction officers is an example of such an offense). The median minimum sentence for Walpole commitments in 1980 was six years. From the table on minimum sentence it can be seen that 14 of the 236 Framingham commitments actually will be serving a state prison sentence.

Maximum Sentence. All individuals committed to the Department of Correction receive a maximum sentence. For Concord commitments this is the only sentence that they receive. The median maximum sentence for Concord commitments is ten years. When considering the Framingham commitments and their maximum sentences, it can be seen that 207 of the 236 commitments to Framingham had less than two years to serve as a maximum sentence and can be considered to

be serving county sentences. In the case of women offenders, unlike their male counterparts, county sentences can be served at a state institution. Of all women then, 207 are serving county sentences, 29 are serving reformatory sentences and 14 are serving state prison sentences. The median maximum sentence for all women at Framingham is less than one year.

Type of Sentence. The modal type of sentence is a simple sentence, this occurred in 48 percent of the cases committed to the department during 1980. However, concurrent sentences are also used with great frequency (38 percent of the cases). A concurrent sentence is one in which two or more sentences resulting from one or more incidents are being served at the same time. Less frequently used are aggregate, forthwith and from and after sentences. In cases of concurrent sentences only the most serious offense and longest sentence are considered.

Type of Offense. The type of offense varies by the committing institution. Walpole commitments are most likely to be for offenses against the person or for sex offenses. Concord commitments are most likely to be for offenses against the person or for property offenses. Framingham commitments are most likely to be for property offenses or for offenses in the "other" category.

These offenses are generally offenses against chastity or public order.

Person offenses account for almost two-thirds of the commitments to Walpole and Concord. The single offense of armed robbery accounts for almost a quarter of all commitments to the Department of Correction. There were 120 cases of individuals being committed for homicides of all types (first and second degree murder and manslaughter). In the category of other person offenses were four cases of mayhem and one case of putting in fear for the purpose of stealing.

Property offenses account for 20 percent of all commitments but about 40 percent of the Framingham commitments. For the male population the most common property offense is burglary and for women the most common property offense is larceny.

Sex offenses account for 10 percent of all commitments to the Department. There were 111 commitments for rape during 1980 and 17 cases for assault with intent to rape. Additionally, there were five cases for unnatural acts which is included with other sex offenses along with a single case of child pornography.

Drug offenses account for only 4 percent of the commitments to the Department. The most common commitment is for a violation of the Controlled Substance Act with a Class A substance.

Finally, offenses in the "other" category account for 8 percent of all commitments but 31 percent of the commitments to Framingham. The most common offense in this category is prostitution for which 39 women were committed. Weapons offenses were the second most common offense in this category. These were 24 commitments for weapons offenses, including commitments under the mandatory gun law.

Time Until Parole Eligibility. An indication of how much time offenders will actually serve is the time until their parole eligibility date. About two-thirds of all offenders will be released at their original parole eligibility date. The median time to serve for all offenders is between 13 and 18 months. For Walpole offenders the median time to serve is from 3 to 5 years. For Concord offenders the median time to serve is from 10 to 12 months and for Framingham commitments the median time to serve is less than three months.

Age at Incarceration. The median age at incarceration is twenty-four years old. It is important to note that this is no younger than previous years. The median age for Walpole commitments is twenty-five years of age, the median age for Concord commitments is twenty-two years of age and the median age for Framingham commitments is twenty-three years of age.

Summary. In 1980 there were 1234 commitments to the Department. These commitments can be divided into three groups by their committing institution. Those offenders committed to the state prison at Walpole tend to be older and more serious offenders. They are sentenced from Superior courts with a median minimum sentence of six years and can expect to serve between three to five years before release. They are likely to be person or sex offenders who have spent time in jail before their commitment. Concord commitments are likely to be serving less than one year until parole eligibility and have median sentence of ten years for a person or property offense. They are younger than Walpole commitments and are less likely to have a large amount of jail time served prior to their commitment. Finally, the Framingham commitments are most likely to be serving county sentences for crimes against chastity and property. They are between the Walpole and Concord commitments in age, are likely to serve less than three months before release and are not likely to have served any time in jail before their commitment to the Department.

Personal Background Characteristics

Sex. All Walpole and Concord commitments are males, all Framingham commitments are females. During 1980, 19 percent of the commitments were females and 81 percent of the commitments to the Department were males.

Race. Two-thirds of the offenders committed in 1980 were whites and one-third were minorities. There were 333 blacks committed to the department (27 percent of the total), 83 hispanics (7 percent) and 4 Asians (1 percent). There were proportionately more minorities committed to Framingham (38 percent) than to Walpole (33 percent) or Concord (32 percent).

Marital Status. Most of the commitments to the Department were single (64 percent). Perhaps reflective of age patterns there were more single individuals committed to Concord (76 percent) than there were to either Framingham (63 percent) or to Walpole (55 percent). Eighteen percent of the commitments were married. Ten percent were divorced and 5 percent were separated at the time of their commitment to the Department.

Military History. Sixteen percent of the commitments to the Department have a history of serving in the military. Of these, most were discharged honorably from the service. Proportionately more veterans were sentenced to Walpole (23 percent).

Prior Address. Almost a third of all commitments to the Department come from the Boston area. Framingham has the highest concentration of such commitments. Almost all of the offenders committed to the Department come from an urban area (SMSA).

Occupation. Almost all of the individuals committed to the Department have previous work experience. For almost half of the commitment population the primary work experience came in the area of manual skills. For women committed to Framingham occupational experience in the clerical and services area were more common. The median time in the position of longest duration was between 7 and 9 months. Walpole commitments averaged slightly longer time on jobs in the past followed by Concord and then Framingham.

Education. The median educational level for this population is the tenth grade. There is little difference in educational level between commitment institutions.

Drug Use. About half of the population evidenced a history of prior drug use (49 percent). Twenty percent of the population had a history of heroin use. Drug use history is generally based on offender self reports or criminal history records.

Summary. The majority of individuals committed to the Department are males. While most of the commitments are whites, minorities are represented more than their presence in the general population would indicate. The offenders are generally single with no military service history and come from the large urban centers of the state. These are generally skilled in manual occupations and have on the average a maximum of between 7 and 9 months of job experience in any position. The median educational level is tenth grade with the vast majority having at least a grade school education.

Criminal History

Prior Court Appearances. The median number of court appearances for this population is 10. As would be expected commitments to Walpole have more prior court appearances than Concord or Framingham commitments. The number of court appearances for person, property, sex, narcotics, drunkenness and escape offenses are also shown.

Prior Incarcerations. About half of the population is presently serving their first incarceration of any type. As would be expected, more of the individuals committed to Walpole have been incarcerated previously than the Concord or Framingham group.

Parole History. About 25 percent of the population experienced paroles in the past. About two-thirds of those with a history of paroles have had parole violations in the past.

Age at Entry Into Crime. The median age of the first court appearance for this population is seventeen years. All three commitment groups are similar on this variable.

Summary. Most of the offenders committed to the Department have had prior contact with the criminal justice system. This experience began on the average at the age of seventeen. Half have experienced a period of incarceration prior to their present commitment. They have appeared in court 9 to 11 times before their present offense. While only a minority have parole experience, that experience did not tend to be successful.
