Abstract

This report is a statistical description of the 2,035 individuals committed by the courts to a term of incarceration in the Massachusetts Department of Correction during the year 1983. The tables in this report contain information on the nature of present offense, personal background characteristics and criminal history of these individuals. Some highlights of the statistics presented in this report are:

- There was a 2 percent increase in the number of commitments during the year, from 2,003 in 1982 to 2,035 in 1983. This is a modest increase in view of the 17 percent increase in 1982 and the 37 percent increase in 1981. It may indicate the beginning of a leveling off of court commitments.
- There were 755 commitments to Walpole (4 percent higher than 1982); 646 commitments to Concord (11 percent lower than 1982); and 634 commitments to Framingham (15 percent higher than 1982).
- Males are committed to Walpole or Concord while females are committed to Framingham. Overall, there was a 4 percent decline in male commitments and a 15 percent increase in female commitments from 1982 to 1983.
- The median minimum sentence for Walpole commitments was six years; the median maximum sentence for Concord commitments was ten years; and the median maximum sentence for Framingham commitments was less than 1 year. Sentence lengths for new court commitments were similar in 1982 and 1983.
- Offenses against the person and sex offenses accounted for 50 percent of all commitments. Armed robbery was the single most common offense. There was a decrease in the proportion of commitments that were for drug offenses and an increase in the proportion of commitments in the "other" offense category.
- The median age at commitment was 25 years, the same as prior years.
- Sixty-nine percent of the commitment population were whites; 66 percent were single; 14 percent had been in the military; 44 percent came from the Boston SMSA; most had limited work experience concentrated in the areas of manual labor and services; the median educational level was eleventh grade; and 28 percent had a self-reported history of drug use.
- Fifty-four percent were serving their first adult incarceration. The median age at first court appearance was seventeen.

## Introduction

This report is a statistical description of individuals committed by the courts to the Massachusetts Department of Correction during 1983. The tables in this report contain information on the nature of the present offense, personal background characteristics and criminal history of admissions from the courts. The information on which this report is based was prepared by the Data Processing Unit of the Research Division.

This report includes all new court commitments as well as those who began serving a new sentence during the year (forthwith and from and after sentences). If an individual was committed to the Department more than once during 1983, that individual is counted as multiple court commitments. Several categories of offenders are not included in this report: those who began serving "B" and "C" sentences during 1983 (sentences received for crimes committed on parole) and those who were sentenced during 1983 but were still in a house of correction awaiting placement in a DOC facility on January 1, 1984. There were 2 individuals awaiting placement on January 1, 1984.

The following information is helpful in reading the tables in this report. Each table is divided according to committing institution. Since each committing institution receives a very different type of offender, it is important to consider each column in the table as well as the total column. The top number in each cell represents the number of individuals who fall into the corresponding category in the table. The bottom number in each cell appears in parentheses and represents

the percentage of the number of individuals in a particular category to the total number of commitments from that institution (column percents).

Cases where information is unknown are also included in the tables and are included in the percentages. It is important to note the size of the "unknown" category. It is particularly large in the criminal history variables where 36 percent are unknown overall and 93 percent are unknown for women committed to Framingham.

### Number of Commitments

There were 2,035 commitments during 1983, a 2 percent increase from the previous year. Figure 1 shows the number of commitments for the period 1973 to 1983. The number of commitments during 1983 was higher than in any of the preceding ten years. The change in commitments from 1982 to 1983 was the smallest increase of any of the preceding five years.

Individuals are committed to one of three institutions: Walpole, Concord or Framingham. Figure 2 shows the number of commitments to each committing institution for the period 1973 to 1983. The number of commitments during 1983 was higher than any of the preceding ten years for Walpole and Framingham but showed a decrease for Concord commitments.

The increase in number of commitments was most dramatic for Framingham, increasing from 549 in 1982 to 634 in 1983, an increase of 85 or 15 percent. In contrast commitments to Walpole increased by 27 or 4 percent and commitments to Concord decreased by 80 or 11 percent. Overall, female commitments increased by 15 percent while male commitments decreased by 4 percent.

Almost all of the increase in Framingham commitments came in the area of

1973 to 1983




property offenses and "other" offenses. Commitments to Framingham for property offenses increased from 210 in 1982 to 229 in 1983 (9 percent) and commitments for "other" offenses increased from 210 in 1982 to 275 in 1983 (31 percent). The increase in commitments in the "other" category was largely due to increases in commitments for prostitution and for operating under the influence. Commitments for prostitution increased from 59 in 1982 to 101 in 1983 (71 percent); commitments for operating under the influence increased from 43 in 1982 to 68 in 1983 (58 percent). Most of the increase in Framingham commitments were women serving county sentences. There were 450 women with county sentences committed in 1982 and 530 in 1983.

For male commitments, those committed to Walpole or Concord, there was a 4 percent decrease from 1982 to 1983. This decrease occurred among Concord commitments only, as Walpole commitments continued to increase although only modestly. This decrease occurred in two offense categories: sex offenses and drug offenses. Commitments for sex offenses decreased from 181 in 1982 to 155 in 1983 (14 percent) and commitments for drug offenses decreased from 166 in 1982 to 100 in 1983 (40 percent). Commitments for person offenses, property offenses and "other" offenses increased by 1 percent, 4 percent and 44 percent respectively. The large increase in the "other" offense category among males was due to an increase in the number of weapons offenders, from 26 in 1982 to 48 in 1983 (85 percent increase).

Thus, in 1983 commitments to the DOC continued to increase although the rate of increase was the lowest in recent years. Increases were due to female commitments as male commitments declined. The increase in female commitments was primarily among women serving county sentences and women committed for property and "other" offenses. Male commitments, particularly Concord commitments and drug offenders, experienced their first decline in recent years.

## A Description of 1983 Court Commitments

This section will present a general description of the population of individuals committed to the DOC during 1983. This discussion includes a description of the present offense, personal background characteristics and criminal history of the offender. Where appropriate, comparisons among the three committing institutions will be done.

### Nature of Present Offense

In discussing the present offense of the commitment group, only the most serious offense, the offense for which the person received the longest sentence, is considered.

Court of Commitment. Seventy percent of the commitments to the Department of Correction were from Superior Courts. Four courts, Suffolk Superior, Middlesex Superior, Hampden Superior and Worcester Superior, accounted for 48 percent of the commitments to the Department. All Walpole commitments came from Superior Courts and 91 percent of all Concord commitments came from Superior Courts. Only 13 percent of the commitments to Framingham were from Superior Courts; most commitments to Framingham were from municipal and district courts (municipal courts are lower courts of Suffolk County and district courts are lower courts of all other counties).

Jail Credits. Jail credits measure the amount of the time that the individual spent incarcerated while awaiting trial. A large number of jail credits is usually indicative of a serious crime or a low income offender. Seventy-eight percent of Walpole commitments had one or more days of jail credits. This contrasts with 64 percent of Concord commitments and 24 percent of Framingham commitments.

The median number of days of jail credits for all commitments was 7.

**Minimum Sentence.** Only those individuals who received a state prison sentence (all Walpole commitments and some Framingham commitments) receive a minimum sentence. Generally minimum prison sentences must be for two and one-half years or more but in some cases can be shorter (some drug offenses carry short prison sentences, for example). The median minimum sentence for Walpole commitments was six years. There were 24 commitments to Framingham who received prison sentences. The median minimum sentence for those women was 5.5 years. Sixty-one individuals received life sentences during 1983.

**Maximum Sentence.** All individuals committed to the Department have a maximum sentence. For Concord commitments this is their only sentence. Generally maximum sentences to Concord are two and one-half years or longer but shorter sentences can be given for some offenses such as larceny, escape and drug offenses. The median maximum sentence for Concord commitments was ten years. A large proportion of Framingham commitments received county sentences, those with a maximum length of less than two and one-half years. Of the 634 commitments to Framingham, 24 (4 percent) received prison sentences, 80 (13 percent) received reformatory sentences and 530 (84 percent) received county sentences, including 65 committed for non-payment of a fine.

**Type of Sentence.** Most individuals committed to the Department received simple sentences (35 percent) or concurrent sentences (37 percent). Less frequently served are aggregate, forthwith, from and after, or split sentences. Split sentences were actually the most common type of sentence used for Framingham commitments, however, and 10 percent of the Framingham commitments were in lieu of payment of a fine.

**Offense.** Type of offense varies by committing institution. Seventy-one percent of the commitments to Walpole and 62 percent of the commitments to

Concord were for person or sex offenses while 36 percent of commitments to Framingham were for property offenses and 43 percent were for offenses in the "other" category.

Offenses against the person accounted for 42 percent of all commitments to the Department but only 12 percent of the commitments to Framingham. Armed robbery accounted for 17 percent of all commitments. There were 124 commitments for homicides in 1983 including 24 for first degree murder, 34 for second degree murder and 66 for manslaughter.

Property offenses accounted for 26 percent of all commitments to the Department, but 36 percent of the commitments to Framingham. Burglary was the most common property offense for Walpole and Concord commitments; larceny was the most common property offense for Framingham commitments.

Sex offenses accounted for 8 percent of all commitments to the DOC. There were 121 commitments for rape during 1983 and 36 commitments for assault with intent to rape. Additionally there were 3 commitments for unnatural acts and 1 for sodomy during the year.

Drug offenses accounted for 7 percent of all commitments during 1983. The most common drug offense was a violation of the controlled substance act with a Class B substance. The Class B substance category includes amphetamines, cocaine, barbituates, and other substances.

Offenses in the "other" category accounted for 5 percent of Walpole commitments, 4 percent of Concord commitments and 43 percent of Framingham commitments. The most common offenses in this category were prostitution (N=101), disturbing the peace (N=58), weapons offenses (N=52), and operating under the influence (N=70). The 7 offenses labelled "other" include: placing explosives at property (N=1), disposal of hazardous waste (N=2), interfering with firefighter (N=1), accessory after the fact (N=1), annoying phone call (N=1) and inhaling toxic vapors (N=1).

**Time Until Parole Eligibility.** An indication of how much time offenders will actually serve is the time until their parole eligibility date. About one-half of all offenders will be released at their original parole date eligibility date. For Walpole commitments the median time to serve was from 3 to 5 years; for Concord commitments the median time to serve was from 10 to 12 months; and for Framingham commitments the median time to serve was less than three months.

**Age At Incarceration.** The median age at incarceration was 25 years. The age of new commitments ranged from 16 years to 69 years. The median age of Walpole commitments was 27.8 years; the median age of Concord commitments was 23.0 years; and the median age of Framingham commitments was 25.8 years.

### **Personal Background Characteristics**

In discussing the personal background characteristics of the commitment population, all information is reported according to the status of the offender at the time of commitment. Most of this information is self-reported by the offender and is not verified in any way.

**Sex.** All Walpole and Concord commitments are males, all Framingham commitments are females. During 1983, 31 percent of the commitments were females and 69 percent were males.

**Race and Ethnicity.** Sixty-nine percent of the 1983 commitment group were white and 30 percent were black. There were also 5 Native Americans and 2 Asians committed to the DOC. Nine percent of the commitment group were Hispanics. This includes white hispanics, black hispanics and other hispanics.

**Marital Status.** Most of the commitment group were single (66 percent). Seventeen percent were married at the time of their commitment, 10 percent were divorced, 6 percent separated and 1 percent widowed.

**Military History.** Fourteen percent of the commitment group had a history of military service. Fifty-seven percent of the known veterans were honorably discharged from military service.

**Prior Address.** Almost all commitments came from Massachusetts. Four counties (Suffolk, Worcester, Middlesex and Hampden) accounted for 68 percent of all commitments.

**Occupation.** Most of the individuals committed to the Department had previous work experience. This work experience was concentrated in the areas of manual labor (35 percent) and services (30 percent). The median length of tenure in a position was 5 to 6 months.

**Education.** The median educational level for this population was eleventh grade. Forty-nine percent of the commitment group had completed at least high school, including 15 percent with some college education.

**Drug Use.** Twenty-eight percent of the commitments reported a history of prior drug use; 11 percent reported a history of heroin use. Drug use history was generally based on offender self reports or criminal history.

### **Criminal History**

Information about the criminal history of individuals committed to the DOC is taken from reports prepared by the Board of Probation. These reports identify the number of court appearances and the offenses that the individual was charged with as well as disposition information. In this section the individual's history of court appearances, charges, incarcerations and paroles will be discussed. It should be noted that criminal history information is not generally available for women committed to Framingham.

**Prior Court Appearances.** The median number of prior court appearances was ten. Eighty-seven percent had court appearances for person offenses, 82 percent for property offenses, 21 percent for sex offenses, 44 percent for narcotics offenses, 22 percent for drunkenness offenses and 9 percent for escape offense.

**Prior Incarcerations.** Eighteen percent had a history of commitments to a juvenile authority; 39 percent had a history of incarcerations in a county facility; and 16 percent had a history of incarcerations in a state or federal facility. Fifty-four percent were serving their first incarceration as an adult.

**Parole History.** The number of paroles and parole violations that an individual experienced prior to this commitment are shown in Tables 38 to 43. About 14 percent of the commitment group experienced paroles in the past. Sixty-six percent of those with a history of paroles also had one or more parole violations.

**Age at Entry Into Criminal Justice System.** Age of the individual at their first court appearance and their first court appearance for a drug related offense or for a drunkenness related offense are shown in Tables 44 to 46. The median age at the time of first court appearance was 17 years of age.
