## Abstract

This report is a statistical description of the 3,794 individuals committed by the courts to a term of incarceration in the Massachusetts Department of Correction during the year 1990. The tables in this report contain information on the nature of present offense, personal background characteristics and criminal history of these individuals. Some highlights of the statistics presented in this report are:

- There was a less than a one percent increase in the number of commitments during the year, from 3,780 in 1989 to 3,794 in 1990. The 3,794 commitments in 1990 represent the highest level of commitments in DOC history.
- There were 1,985 commitments to Cedar Junction (5 percent higher than 1989), 1,104 commitments to Framingham (3 percent lower than 1989), and 705 commitments to Concord (6 percent lower than 1989).
- Males are committed to Cedar Junction or Concord while females are committed to Framingham. Overall, there was an increase of 2 percent in male commitments and a decrease of 3 percent in female commitments from 1989 to 1990.
- The median minimum sentence for Cedar Junction commitments was five years; the median maximum sentence for Concord commitments was five years; and the median maximum sentence for Framingham commitments was less than 1 year. Sentence lengths for new court commitments were similar in 1989 and 1990, for Walpole and Framingham commitments, but were shorter for Concord commitments.
- Violent offenses (person and sex) accounted for 49 percent of all male commitments and 9 percent of all female commitments. Non-violent offenses (property, drug and "other") represented 91 percent of all female commitments and 51 percent of all male commitments. From 1989 to 1990 there were increases in commitments for drug offenses and person offenses. There were decreases in commitments for sex offenses, property offenses, and "other" offenses.
- The median age at commitment was 28 years.
- Fifty percent of the commitment population were white, 27 percent were African American, 22 percent were hispanic, and one percent were other races.
- Fifty-four percent of those committed were serving their first adult incarceration and 46 percent had one or more prior adult incarcerations.

## Introduction

This report is a statistical description of individuals committed by the courts to the Massachusetts Department of Correction during 1990. The report contains information on the nature of the present offense, personal background characteristics, and criminal history of individuals committed from the courts. Trends in court commitments over the last five to ten years are discussed as well. This report is based on information that was submitted to the Research Division from the three committing institutions and the Board of Probation.

This report includes all new court commitments as well as those who began serving a new sentence during the year. If an individual was committed to the Department more than once during 1990, each court commitment for that individual is counted separately. Some categories of offenders are not included in this report, for example, those who began serving "B" and "C" sentences during 1990 (sentences received for crimes committed on parole).

The following information is helpful when reading the tables in this report. Each table is divided according to committing institution. Since each committing institution receives a different type of offender, it is important to consider each column in the table as well as the total column. The columns marked "N" represent the number of individuals who fall into the corresponding category in the table. The columns marked "%" represent the percentage of the number of

individuals in a particular category to the total number of commitments from that institution (column percents).

Cases where information is unknown are also included in the tables and are included in the percentages. It is important to note the size of the "unknown" category. The number of unknown cases is high for some of the personal background characteristics variables. In the narrative, these cases are excluded when discussing percentages.

## Trends in Court Commitments, 1980 to 1990

There were 3,794 commitments during 1990, less than a one percent increase from the previous year. Figure 1 shows the number of commitments for the period 1980 to 1990. The number of commitments during 1990 was higher than at any time in the history of the DOC.

Individuals are committed to one of three institutions: Cedar Junction, Concord or Framingham. Figure 2 shows the number of commitments to each committing institution for the period 1980 to 1990. The number of commitments during 1990 was higher than any of the preceding ten years for Cedar Junction. Commitments to Concord and Framingham decreased in 1990 from previous levels.

From 1989 to 1990 changes in commitment levels varied at the three committing institutions. Cedar Junction commitments increased from 1,888 in

Court Commitments, 1980 to 1990




1989 to 1,985 in 1990, an increase of 97 commitments or 5 percent. Concord commitments decreased from 750 in 1989 to 705 in 1990 a decrease of 45 commitments or 6 percent. Framingham decreased from 1,142 commitments in 1989 to 1,104 in 1990, a decrease of 38 commitments or 3 percent. Overall, male commitments increased by 2 percent and female commitments decreased by 3 percent.

Table 1 shows selected characteristics of offenders committed to the DOC over the last six years, 1985 to 1990. These characteristics are shown separately for each committing institution and for total commitments.

The primary offense for which individuals are committed to the DOC has changed over the past six years. Commitments for drug offenses increased by 243 percent (N=873); commitments for sex offenses increased by 36 percent (N=92); commitments for person offenses increased by 30 percent (N=245); commitments for other offenses increased by 21 percent (N=73); and commitments for property offenses increased 16 percent (N=102). In 1985, 45 percent of DOC commitments were for violent offenses (i.e. person and sex offenses) and 55 percent were for non-violent offenses (i.e. property, drug, and "other" offenses). In 1990, 37 percent of the commitments were for violent offenses and 63 percent were for non-violent offenses.

Commitments for drug offenses increased 243 percent over the six year period (N=873). Drug commitments

increased at all three committing institutions, but most notably at Cedar Junction and Framingham. Drug commitments were up by 399 percent (N=611) at Cedar Junction, by 254 percent (N=244) at Framingham, and by 16 percent (N=18) at Concord.

Commitments for sex offenses increased by 36 percent (N=92) over the period, from 252 in 1985 to 344 in 1990. All three institutions experienced increases in commitments for sex offenses. Commitments for sex offenses to Cedar Junction increased by 45 percent (N=71), commitments for sex offenses to Concord increased by 16 percent (N=15), and commitments for sex offenses to Framingham increased by six commitments, from one in 1985 to 7 in 1990. Commitments for sex offenses involving a minor (rape of child or indecent assault and battery of child) increased from 131 in 1985 to 201 in 1990. Commitments for sex offenses involving an adult victim (aggravated rape, rape, or indecent assault and battery) increased from 118 in 1985 to 141 in 1990.

The number of offenders committed for offenses against the person increased by 30 percent, from 830 in 1985 to 1,075 in 1990. Commitments for person offenses increased at Cedar Junction by 51 percent (N=245) and at Framingham by 10 percent (N=9); and decreased at Concord by 3 percent (N=9) during the past six years.

Commitments for offenses in the "other" offense category increased by 21

percent (N=73) over the past six years. For Framingham, this category includes commitments for prostitution, common night walker, O.U.I., disturbing the peace, or other offenses in this category. For Walpole and Concord, this category includes predominantly weapons offenses. Commitments to Framingham in this category increased by 5 percent (N=16) over the period. Commitments to Cedar Junction for "other" offenses increased by 33 commitments, and those to Concord increased by 24 commitments.

Commitments for property offenses increased 16 percent over the six year period (N=102). Commitments for property offenses increased at Cedar Junction by 18 percent (N=32), at Framingham by 10 percent (N=30), and at Concord by 28 percent (N=40).

Patterns in sentence length over the past six years is considered separately for each committing institution. Upon comparing the distribution of sentence length for Cedar Junction during 1985 with 1990, the proportion of commitments for sentences of less than 5 years stayed about the same, 39 percent in 1985 and 38 percent in 1990, the proportion of commitments for sentences of 5-9 years and commitments for sentences of 10-15 years increased from 39 percent and 11 percent to 42 percent and 14 percent, respectively. Commitments with sentences of 16 years or more (including life), changed from 109 in 1985 (11 percent of commitments) to 114 in 1990 (6 percent of commitments).

Concord sentence lengths changed

from 1985 to 1990. The proportion of 1990 commitments with sentence lengths of less than 10 years increased from 39 percent in 1985 to 55 percent in 1990. The proportion of Concord commitments with sentences of 10 years or more decreased from 61 percent in 1985 to 45 percent in 1990.

Women committed to Framingham can serve either a county, reformatory, or prison sentence. Over the past six years the number of women committed with prison sentences increased 470 percent (N=108), the number of women committed with county sentences increased 22 percent (N=163), and the number of women committed with reformatory sentences increased 74 percent (N=34). Overall, in 1985, 91 percent of Framingham commitments were for county sentences and 9 percent were for state prison or reformatory sentences and in 1990, 81 percent were commitments for county sentences and 19 percent were for state prison or reformatory sentences.

The age distribution of individuals committed to the Department shifted upward over this six year period. In 1985, 62 percent of the commitments were under 30 and 38 percent were 30 years or older. By 1990, 57 percent were under 30 and 43 percent were 30 years or older. This shift in age distribution was most pronounced among commitments to Framingham.

### A Description of 1990 Court Commitments

This section presents a description of the population of individuals committed to the DOC during 1990. This discussion includes a description of the present offense, personal background characteristics, and criminal history of the offender. Where appropriate, the three committing institutions are compared.

#### Nature of Present Offense

In discussing the present offense of the commitment population, the governing offense is represented. This is the offense for which the person received the longest sentence.

Court of Commitment. Seventy-one percent of the commitments to the Department of Correction were from Superior Courts. Four courts, Suffolk Superior, Hampden Superior, Middlesex Superior and Worcester Superior, accounted for 51 percent of the commitments to the Department. All Cedar Junction commitments came from Superior Courts and 74 percent of all Concord commitments came from Superior Court. In contrast, 18 percent of the commitments to Framingham were from Superior Courts. Most commitments to Framingham were from municipal and district courts (municipal courts are lower courts of Suffolk County, Brookline Municipal Court is the lower court of Norfolk County and district courts are lower courts of all other counties).

Jail Credits. Jail credits represent the number of days that the individual was incarcerated while awaiting trial. A large number of jail credits is usually indicative of a serious crime or a low income offender. Seventy-six percent of Cedar Junction commitments had one or more days of jail credits. This contrasts with 50 percent of Concord commitments and 33 percent of Framingham commitments. The median number of jail credits for all commitments was 12. This includes 41 percent (N=1,571) with no jail credits.

Minimum Sentence. Only those individuals who receive a state prison sentence (all Cedar Junction commitments and some Framingham commitments) receive a minimum sentence. Generally, minimum state prison sentences must be for two and one-half years or more but in some cases can be shorter (for example, some drug offenses carry short prison sentences). The median minimum sentence for Cedar Junction commitments was five years. There were 131 commitments to Framingham who received state prison sentences. The median minimum sentence for those women was five years.

Sixty-seven individuals received life sentences during 1990. The 67 life sentences included 28 for first-degree murder, 32 for second-degree murder, 4 for other person offenses, and 3 for sex offenses.

Maximum Sentence. All individuals committed to the DOC have a maximum sentence. For Concord commitments this is their only sentence.

Generally, maximum sentences to Concord are two and one-half years or longer but shorter sentences can be given for some offenses such as larceny, escape and drug offenses. The median maximum sentence for Concord commitments was five years. A large proportion of Framingham commitments received county sentences, those with a maximum sentence length of less than two and one-half years. Males receiving county sentences are committed to houses of correction. Many females receiving county sentences were committed to Framingham. Of the 1,104 commitments to Framingham, 131 (12 percent) received prison (Cedar Junction) sentences, 80 (7 percent) received reformatory (Concord) sentences and 893 (81 percent) received county sentences, including 105 committed for non-payment of a fine.

**Type of Sentence.** Most individuals committed to the Department received simple sentences (34 percent) or concurrent sentences (37 percent). Split sentences are commonly found among Concord (18 percent) and Framingham (23 percent) commitments. Less frequently received are aggregate, forthwith or from-and-after sentences. Forthwith sentences are commonly found among Cedar Junction commitments (12 percent). Ten percent of the Framingham commitments were in lieu of payment of a fine.

**Offense.** Type of offense varied by committing institution. Forty-nine percent of the commitments to Cedar Junction and 51 percent of the commitments to Concord were for violent offenses. In contrast, 9 percent of the

commitments to Framingham were for violent offenses. Most women were committed for drug offenses (31 percent), property offenses (30 percent), or "other" offenses (30 percent).

Offenses against the person accounted for 28 percent of all commitments to the Department varying from 37 percent to Cedar Junction, 36 percent to Concord, and 9 percent to Framingham. The most common offenses against the person were armed robbery (N=366), armed assault (N=257), and unarmed robbery (N=173). There were 145 commitments for homicides in 1990, including 28 for first degree murder, 32 for second degree murder, 59 for manslaughter, and 26 for vehicular homicide.

Sex offenses accounted for nine percent of all commitments to the DOC including 12 percent to Cedar Junction, 15 percent to Concord, and one percent to Framingham. There were 249 commitments for rape during 1990 and 93 commitments for sexual assaults. Of the rapes and sexual assaults, 141 involved adult victims and 201 involved minors. Additionally, there were 2 commitments for other sex offenses during 1990.

Property offenses accounted for 19 percent of all commitments to the Department, varying from 11 percent to Cedar Junction, 26 percent to Concord, and 30 percent to Framingham. Burglary was the most common property offense for Cedar Junction and Concord commitments; larceny was the most common property offense for Framingham commitments.

Drug offenses accounted for 32 percent of all commitments during 1990 varying from 38 percent to Cedar Junction, 18 percent to Concord, and 31 percent to Framingham. There were 515 commitments whose governing offense was a mandatory drug offense.

Offenses in the "other" category accounted for 3 percent of Cedar Junction commitments, 5 percent of Concord commitments and 30 percent of Framingham commitments, or 11 percent of all commitments to the DOC. The most common offenses in this category were operating under the influence (N=88), weapons offenses (N=87), prostitution (N=78), motor vehicle offenses (N=58) and disturbing the peace (N=39).

**Number of Charges.** Forty-eight percent of the commitments to the DOC had one charge for which they are currently incarcerated, and fifty-two percent were currently incarcerated for more than one charge. The number of charges that resulted in the current commitment ranged from 1 to 75.

**Time Until Parole Eligibility.** An indication of how much time offenders will actually serve is the time until their parole eligibility date. For Cedar Junction commitments the median time to serve was from 2 to 3 years; for Concord commitments the median time to serve was from 10 to 12 months; and for Framingham commitments the median time to serve was 3 months or less.

Individuals can have no parole eligibility for a number of reasons. Some

mandatory sentences have no possible release to parole and some sentences are too short for parole eligibility to be established, i.e., less than sixty days. In a small number of cases, individuals can be beyond their original parole eligibility at the time of commitment to the DOC if they were in jail for a sufficient time awaiting sentencing.

### **Personal Background Characteristics**

In discussing the personal background characteristics of the commitment population, all information is reported according to the status of the offender at the time of commitment. This information is self-reported by the offender and is not verified in any way.

**Age at Incarceration.** The median age of offenders at incarceration was 28 years. Their ages ranged from 16 years to 77 years. The median age of Cedar Junction commitments was 28 years; the median age of Concord commitments was 25 years; and the median age of Framingham commitments was 29 years.

**Sex.** All Cedar Junction and Concord commitments are males. All Framingham commitments are females. During 1990, 29 percent of the commitments were females and 71 percent were males.

**Race and Ethnicity.** Fifty percent of the 1990 commitment group were white, 27 percent were African American, and 22 percent were identified as Hispanic. There were also 7 Native

Americans and 33 Asians committed to the DOC.

**Citizenship.** Ninety-three percent of the commitments were U.S. citizens and 7 percent were citizens of other countries. Fifty-eight percent of the commitments were born in Massachusetts, 20 percent were born in other states, 12 percent were born in U.S. territories, and 3 percent were U.S. citizens born in other countries.

**Marital Status.** Most of the commitment group were single (66 percent). Eighteen percent were married, 5 persons were common law at the time of their commitment, 10 percent were divorced, 4 percent were separated, and one percent were widowed.

**Military History.** Of the offenders committed to Cedar Junction, 14 percent (N=288) reported a history of military service of these 74 percent (N=214) were honorably discharged from the military. Only a small number of offenders committed to Framingham report a history of military service (N=4).

**Prior Address.** Almost all commitments (94 percent) were living in Massachusetts prior to incarceration. Of these, three communities accounted for 40 percent of the commitments: Boston (N=816), Springfield (N=435), and Worcester (N=276).

**Occupation.** Of the offenders committed to Cedar Junction, work experience was concentrated in the areas of manual labor (56 percent) and services (32 percent).

**Education.** The median educational level for this population was grade 12. Fifty-two percent of the commitment group had received a GED or completed high school, including 9 percent with some college education.

### **Criminal History**

In this section the individual's history of court appearances, charges, incarcerations, defaults and probations will be discussed. Information about the criminal history of individuals committed to the DOC is taken from Superior Court Reports or automated reports prepared by the Board of Probation. These reports identify the number of arraignments and the offenses that the individual was charged with as well as disposition information.

**Court Appearances.** The number of court appearances represents the number of separate dates on which an offender was arraigned on new charges. The median number of prior court appearances was eight. The court record is also reviewed for the number of arraignments for a variety of offense types. Sixty-three percent had one or more arraignments for person offenses, 68 percent for property offenses, 16 percent for sex offenses, 66 percent for drug offenses, 21 percent for alcohol offenses, and 6 percent for escape offenses.

**Prior Incarcerations.** Of the offenders committed in 1990, 44 percent had a history of incarceration for a county sentence; and 9 percent had a history of incarceration for a state or federal

sentence. Fifty-four percent were serving their first incarceration as an adult and 46 percent had one or more prior adult incarcerations.

**Prior Probations.** Of the offenders committed in 1990, 64 percent had a history of one or more prior periods of probation supervision and 36 percent had no probation supervisions prior to the current commitment.

**Prior Defaults.** Of the offenders committed in 1990, 69 percent had one or more defaults on their criminal record and 31 percent had no defaults on their criminal record.

**Age at Entry into Criminal Justice System.** The age of the individual at first court appearance, first court appearance for a drug related offense, and first court appearance for an alcohol related offense are shown in the tables. The median age at the time of first court appearance was 20 years of age.

**GLOSSARY**

**MINIMUM SENTENCE/  
MAXIMUM SENTENCE**

In the tables minimum and maximum sentence lengths are truncated to the closest whole year. For example, a sentence of 5 years 1 day is included in the 5 year category.

**OFFENSE**

**Armed Assault**

Includes armed assault with intent to rob, armed assault in dwelling house, assault and battery with dangerous weapon, and assault with dangerous weapon.

**Assault-Intent to Murder**

Includes assault with intent to murder and attempt to murder.

**Assault with Intent to Rape**

Includes assault with intent to rape and indecent assault and battery.

**Other Person**

Includes confining a person for the purpose of stealing, and violation of civil rights.

**Rape of Minor**

Includes rape of female under sixteen, rape of child, and statutory rape.

**Unarmed Assault**

Includes unarmed assault with intent to rob, assault, assault and battery, and other assaults.

**SENTENCE TYPE**

**Aggregate**

Multiple sentences received for more than one offense. These sentences will be served consecutively. The sentence length reported reflects the total of all sentences.

**Concurrent**

Multiple sentences received for more than one offense. These sentences will be served simultaneously.

**GLOSSARY** (Cont.)

<b>Fine</b>	Incarceration resulting from non-payment of a fine for one or more offenses.
<b>Forthwith</b>	A sentence that is to be served effective immediately, regardless of other sentences for which the individual is currently incarcerated.
<b>From and After</b>	A sentence to be served following release from a previous sentence.
<b>Simple</b>	One sentence received for a single offense.
<b>Split</b>	A sentence that is divided between a specified period of incarceration followed by probation supervision.
