Abstract

This report is a statistical description of the 3,737 individuals committed by the courts to a term of incarceration in the Massachusetts Department of Correction during the year 1991. The tables in this report contain information on the nature of present offense, personal background characteristics and criminal history of these individuals. Some highlights of the statistics presented in this report are:

- There was one percent decrease in the number of commitments during the year, from 3,794 in 1990 to 3,737 in 1991. The 3,737 commitments in 1991 represent the first decrease in commitments over the last 10 years.
- There were 2,042 commitments to Cedar Junction (3 percent higher than 1990), 1,009 commitments to Framingham (9 percent lower than 1990), and 686 commitments to Concord (3 percent lower than 1990).
- Males are committed to Cedar Junction or Concord, while females are committed to Framingham. Overall, there was an increase of 1 percent in male commitments and a decrease of 9 percent in female commitments from 1990 to 1991.
- The median minimum sentence for Cedar Junction commitments was five years; the median maximum sentence for Concord commitments was five years; and the median maximum sentence for Framingham commitments was less than 1 year. Sentence lengths for new court commitments were similar for 1990 and 1991.
- Violent offenses (person and sex) accounted for 54 percent of all male commitments and 13 percent of all female commitments. Non-violent offenses (property, drug and "other") represented 87 percent of all female commitments and 46 percent of all male commitments. From 1990 to 1991 there were increases in commitments for person offenses and sex offenses. There were decreases in commitments for property offenses, drug offenses, and "other" offenses. Overall, the proportion of commitments for violent offenses increased when compared with 1990 for both male and female commitments.
- The median age at commitment was 28 years.
- Fifty percent of the commitment population were white, 28 percent were African American, 21 percent were Hispanic, and one percent were other races.
- Fifty-four percent of those committed were serving their first adult incarceration and 46 percent had one or more prior adult incarcerations.

Introduction

This report is a statistical description of individuals committed by the courts to the Massachusetts Department of Correction during 1991. The report contains information on the nature of the present offense, personal background characteristics, and criminal history of individuals committed from the courts. Trends in court commitments over the last six to ten years are discussed as well. This report is based on information that was submitted to the Research Division from the three committing institutions and the Board of Probation.

This report includes all new court commitments as well as those who began serving a new sentence during the year. If an individual was committed to the Department more than once during 1991, each court commitment for that individual is counted separately. Some categories of offenders are not included in this report, for example, those who began serving "B" and "C" sentences during 1991 (sentences received for crimes committed on parole).

The following information is helpful when reading the tables in this report. Each table is divided according to committing institution. Since each committing institution receives a different type of offender, it is important to consider each column in the table as well as the total column. The columns marked "N" represent the number of individuals who fall into the corresponding category in the table. The columns marked "%" represent the percentage of the number of individuals in a particular category to the total number of commitments from that institution (column percents).


Cases where information is unknown are also included in the tables and are included in the percentages. It is important to note the size of the "unknown" category. The number of unknown cases is high for some of the

personal background characteristics variables. In the narrative, these cases are excluded when discussing percentages.

Trends in Court Commitments, 1981 to 1991

There were 3,737 commitments during 1991, a one percent decrease from the previous year. Figure 1 shows the number of commitments for the period 1981 to 1991. Excluding 1991, the number of commitments has increased each year since 1981.

Court Commitments, 1981 to 1991**




Individuals are committed to one of three institutions: Cedar Junction, Concord or Framingham. Figure 2 shows the number of commitments to each committing institution for the period 1981 to 1991. The number of commitments during 1991 was higher than any of the preceding ten years for Cedar Junction. Commitments to Concord and Framingham decreased in 1991 from previous levels.

From 1990 to 1991 changes in commitment levels varied at the three committing institutions. Cedar Junction commitments increased from 1,985 in 1990 to 2,042 in 1991, an increase of 57 commitments or 3 percent. Concord commitments decreased from 705 in 1990 to 686 in 1991 a decrease of 19 commitments or 3 percent. Framingham

decreased from 1,104 commitments in 1990 to 1,009 in 1991, a decrease of 95 commitments or 9 percent. Overall, male commitments increased by 1 percent and female commitments decreased by 9 percent.

Trends in Court Commitments,
1986 to 1991

Table 1 shows selected characteristics of offenders committed to the DOC over the last six years, 1986 to 1991. These characteristics are shown separately for each committing institution and for total commitments.

Overall, the number of commitments increased 48 percent (N=1,204) from 2,533 commitments in 1986 to 3,737 commitments in 1991.

Present Offense

In 1986, 42 percent of DOC commitments were for violent offenses (i.e. person and sex offenses) and 58 percent were for non-violent offenses (i.e. property, drug, and "other" offenses). In 1991, 43 percent of the commitments were for violent offenses and 57 percent were for non-violent offenses.

The primary offense for which individuals are committed to the DOC has changed over the past six years. More

specifically, commitments for drug offenses increased by 109 percent (N=556); commitments for person offenses increased by 57 percent (N=447); commitments for sex offenses increased by 36 percent (N=95); commitments for property offenses increased by 16 percent (N=91); and commitments for "other" offenses increased 4 percent (N=15).

Commitments for drug offenses increased 109 percent over the six year period (N=556). Drug commitments increased at Cedar Junction and Framingham while they decreased at Concord. Drug commitments were up by 191 percent (N=442) at Cedar Junction, and 109 percent (N=151) at Framingham, while they were down by 26 percent (N=37) at Concord.

The number of offenders committed for offenses against the person increased by 57 percent, from 789 in 1986 to 1,236 in 1991. Commitments for person offenses increased at Cedar Junction by 81 percent (N=375), at Framingham by 74 percent (N=49); and at Concord by 9 percent (N=23) during the past six years.

Commitments for sex offenses increased by 36 percent (N=95) over the period, from 265 in 1986 to 360 in 1991. All three institutions experienced increases in commitments for sex offenses. Commitments for sex offenses to Cedar Junction increased by 53 percent (N=83), commitments for sex offenses to Concord increased by 8 percent (N=8), and commitments for sex offenses to Framingham increased by four commitments, from ten in 1986 to 14 in 1991. Commitments for sex offenses involving a minor (rape of child or indecent assault and battery of child) increased from 154 in 1986 to 217 in 1991. Commitments for sex offenses involving an adult victim (aggravated rape, rape, or indecent assault and battery) increased from 103 in 1986 to 139 in 1991.

Commitments for property offenses increased 16 percent over the six year period (N=91). Commitments for property offenses increased at Cedar Junction by 50 percent

(N=78), at Concord by 8 percent (N=11), and at Framingham by 1 percent (N=2).

Commitments for offenses in the "other" offense category increased by 4 percent (N=15) over the past six years. For Framingham, operating under the influence of alcohol, prostitution, disturbing the peace, common night walker, motor vehicle offenses, and trespassing are the most common offenses in the "other" offense category. For Cedar Junction and Concord, this category includes predominantly weapons offenses.

Commitments to Cedar Junction for "other" offenses increased by 31 commitments, and those to Concord increased by 19 commitments. Commitments to Framingham in this category decreased by 10 percent (N=35) over the period.

Sentence Length

Patterns in sentence length over the past six years is considered separately for each committing institution. Upon comparing the distribution of sentence length for Cedar Junction commitments during 1986 with 1991, the proportion of commitments for sentences of less than 5 years decreased from 40 percent in 1986 to 36 percent in 1991, the proportion of commitments for sentences of 5-9 years increased from 39 percent in 1986 to 44 percent in 1991, and the proportion of commitments for sentences of 10-15 years increased from 13 percent in 1986 to 14 percent in 1991. The proportion of commitments with sentences of 16 years or more (including life), decreased from 8 percent in 1986 to 6 percent in 1991.

Sentence length distribution also changed for Concord commitments from 1986 to 1991. The proportion of 1991 commitments with sentence lengths of less than 5 years increased from 11 percent in 1986 to 23 percent in 1991. The proportion of Concord commitments with sentences of 5 years or more decreased from 89 percent in 1986 to 76 percent in 1991.

Women committed to Framingham can serve either a county, reformatory, or state prison sentence. Over the past six years the number of women committed with state prison sentences increased 185 percent (N=74), the number of women committed with reformatory sentences increased 32 percent (N=18), and the number of women committed with county sentences increased 11 percent (N=79). Overall, in 1986, 88 percent of Framingham commitments were for county sentences and 12 percent were for state prison or reformatory sentences and in 1991, 81 percent were commitments for county sentences and 19 percent were for state prison or reformatory sentences.

Age at Incarceration

The age distribution of individuals committed to the Department shifted upward over the six year period. In 1986, 62 percent of the commitments were under 30 years and 38 percent were 30 years or older. By 1991, 59 percent were under 30 years and 41 percent were 30 years or older. This shift in age distribution was most pronounced among commitments to Framingham. In 1986, 62 percent of the commitments were under 30 years and 38 percent were 30 years or older. By 1991, 54 percent of the commitments were under 30 years and 46 percent were 30 years or older.

A Description of 1991 Court Commitments

This section presents a description of the population of individuals committed to the DOC during 1991. This discussion is based on information presented in the tables beginning at page 11 of this report. It includes a description of the present offense, personal background characteristics, and criminal history of the offender. Where appropriate, the three committing institutions are compared.

Nature of Present Offense

In discussing the present offense of the commitment population, the governing offense is represented. This is the offense for which the person received the longest sentence.

Court of Commitment. Seventy-three percent of the commitments to the Department of Correction were from Superior Courts. Four courts, Suffolk Superior, Middlesex Superior, Hampden Superior and Worcester Superior accounted for 51 percent of the commitments to the Department. All Cedar Junction commitments came from Superior Courts and 70 percent of all Concord commitments came from Superior Court. In contrast, 20 percent of the commitments to Framingham were from Superior Courts. Most commitments to Framingham were from municipal and district courts (municipal courts are lower courts of Suffolk County, Brookline Municipal Court is a lower court of Norfolk County and district courts are lower courts of all other counties).

Jail Credits. Jail credits represent the number of days that the individual was incarcerated while awaiting trial. A large number of jail credits is usually indicative of a serious crime or a low income offender. Seventy-six percent of Cedar Junction commitments had one or more days of jail credits. This contrasts with 53 percent of Concord commitments and 34 percent of

Framingham commitments. The median number of jail credits for all commitments was 12. This includes 40 percent (N=1,482) with no jail credits.

Minimum Sentence. Only those individuals who receive a state prison sentence (all Cedar Junction commitments and some Framingham commitments) receive a minimum sentence. Generally, minimum state prison sentences must be for two and one-half years or more but in some cases can be shorter (for example, some drug offenses carry short prison sentences). The median minimum sentence for Cedar Junction commitments was five years. There were 114 commitments to Framingham for state prison sentences. The median minimum sentence for those women was four years.

Seventy-five individuals received life sentences during 1991. The 75 life sentences included 20 for first-degree murder, 49 for second-degree murder, 3 for other person offenses, and 3 for sex offenses.

Maximum Sentence. All individuals committed to the DOC have a maximum sentence. For Concord commitments this is their only sentence. Generally, maximum sentences to Concord are two and one-half years or longer but shorter sentences can be given for some offenses such as larceny, escape and drug offenses. The median maximum sentence for Concord commitments was five years. A large proportion of Framingham commitments received county sentences, those with a maximum sentence length of less than two and one-half years. Males receiving county sentences are committed to houses of correction while many of the females receiving county sentences are committed to Framingham. Of the 1,009 commitments to Framingham, 114 (11 percent) received state prison (Cedar Junction) sentences, 75 (7 percent) received reformatory (Concord) sentences and 820 (81 percent) received county sentences, including 57 committed for non-payment of a fine.

Type of Sentence. Most individuals committed to the Department during 1991 received simple sentences (37 percent) or concurrent sentences (36 percent). Seventeen percent of the commitments received split sentences; Cedar Junction (15 percent), Concord (16 percent) and Framingham (20 percent). Less frequently received are aggregate, forthwith, or from-and-after sentences. Forthwith sentences are commonly found among Cedar Junction commitments (10 percent). Six percent of the Framingham commitments were in lieu of payment of a fine.

Offense. Type of offense varied by committing institution. Fifty-three percent of the commitments to Cedar Junction and 57 percent of the commitments to Concord were for violent offenses (person or sex offenses). In contrast, 13 percent of the commitments to Framingham were for violent offenses. Most women were committed for "other" offenses (32 percent), drug offenses (29 percent), or property offenses (27 percent).

Offenses against the person accounted for 33 percent of all commitments to the Department varying from 41 percent for Cedar Junction and Concord, to 11 percent for Framingham. The most common offenses against the person were armed robbery (N=427), armed assault (N=321), and unarmed robbery (N=158). There were 188 commitments for homicides in 1991, including 20 for first degree murder, 49 for second degree murder, 89 for manslaughter, and 30 for vehicular homicide. The number of commitments for first-degree murder decreased by 8, while the number of commitments in the other homicide categories increased by 51 from 1990.

Sex offenses accounted for ten percent of all commitments to the DOC including 12 percent to Cedar Junction, 16 percent to Concord, and one percent to Framingham. There were 289 commitments for rape during 1991 and 67 commitments for sexual assaults. Of the rapes and sexual assaults, 139 involved adult victims and 217 involved minors.

Additionally, there were 4 commitments for other sex offenses during 1991.

Property offenses accounted for 18 percent of all commitments to the Department, varying from 11 percent to Cedar Junction, 22 percent to Concord, and 27 percent to Framingham. Burglary was the most common property offense for Cedar Junction and Concord commitments; larceny was the most common property offense for Framingham commitments.

Drug offenses accounted for 29 percent of all commitments during 1991 varying from 33 percent to Cedar Junction, 15 percent to Concord, and 29 percent to Framingham. There were 466 commitments whose governing offense was a mandatory drug offense, 44 percent of all drug commitments.

Offenses in the "other" category accounted for 3 percent of Cedar Junction commitments, 6 percent of Concord commitments, and 32 percent of Framingham commitments, or 11 percent of all commitments to the DOC. The most common offenses in this category for Framingham commitments were operating under the influence (N=96), prostitution (N=53), disturbing the peace (N=40), common nightwalker (N=39), motor vehicle (N=38), and trespassing (N=34). Cedar Junction and Concord commitments for "other" offenses consisted mostly of weapons offenses (N=65).

Number of Charges. Fifty-one percent of the commitments to the DOC had one charge for which they are currently incarcerated, and forty-nine percent were currently incarcerated for more than one charge. The number of charges that resulted in the current commitment ranged from 1 to 75.

Time Until Parole Eligibility. An indication of how much time offenders will actually serve is the time until their parole eligibility date. For Cedar Junction commitments the median time to serve was

from 2 to 3 years; for Concord commitments the median time to serve was from 10 to 12 months; and for Framingham commitments the median time to serve was 3 months or less.

Individuals can have no parole eligibility for a number of reasons. Some mandatory sentences have no possible release to parole and some sentences are too short for parole eligibility to be established, i.e., less than sixty days. In a small number of cases, individuals can be beyond their original parole eligibility at the time of commitment to the DOC if they were in jail for a sufficient time awaiting sentencing.

Personal Background Characteristics

In discussing the personal background characteristics of the commitment population, all information is reported according to the status of the offender at the time of commitment. This information is reported by the offender and is not verified in any way.

Age at Incarceration. The median age of offenders at incarceration was 28 years. Their ages ranged from 17 years to 76 years. The median age of Cedar Junction commitments was 28 years; the median age of Concord commitments was 24 years; and the median age of Framingham commitments was 29 years.

Sex. All Cedar Junction and Concord commitments are males. All Framingham commitments are females. During 1991, 27 percent of the commitments were females and 73 percent were males.

Race and Ethnicity. Fifty percent of the 1991 commitment group were Caucasian, 28 percent were African American, and 21 percent were identified as Hispanic. There were also 10 Native Americans and 22 Asians committed to the DOC.

Citizenship. Ninety-five percent of the commitments were U.S. citizens and 5 percent were citizens of other countries. Sixty

percent of the commitments were born in Massachusetts, 20 percent were born in other states, 11 percent were born in U.S. territories, and 5 percent were U.S. citizens born in other countries.

Marital Status. Most of the commitment group were single (70 percent). Seventeen percent were married, 2 persons were common law at the time of their commitment, 8 percent were divorced, 4 percent were separated, and one percent were widowed.

Military History. Of the offenders committed to Cedar Junction, 12 percent (N=248) reported a history of military service. Of these, 79 percent (N=196) were honorably discharged from the military. Only a small number of offenders committed to Framingham reported a history of military service (N=5).

Prior Address. Almost all commitments (95 percent) were living in Massachusetts prior to incarceration. Of these, three communities accounted for 40 percent of the commitments: Boston (N=869), Springfield (N=332), and Worcester (N=233).

Occupation. Of the offenders committed to Cedar Junction, work experience was concentrated in the areas of manual labor (50 percent) and service (36 percent). Occupation information was not reported for 98 percent of the Concord commitments and 87 percent of the Framingham commitments.

Education. The median educational level was 11th grade for persons committed to Cedar Junction and 12th grade for persons committed to Framingham. Forty-nine percent of the commitment group had received a GED or completed high school, including 9 percent with some college education. Concord is excluded from this analysis since education information was not reported for 97 percent of the commitments.

Criminal History

In this section the individual's history of court appearances, charges, incarcerations, defaults and probations will be discussed. Information about the criminal history of individuals committed to the DOC is taken from Superior Court Reports or automated reports prepared by the Board of Probation. These reports identify the number of arraignments and the offenses that the individual was charged with as well as disposition information.

Court Appearances. The number of court appearances represents the number of separate dates on which an offender was arraigned on new charges prior to their present commitment. The median number of prior court appearances was nine. The court record is also reviewed for the number of arraignments for a variety of offense types. Sixty-six percent had one or more arraignments for person offenses, 71 percent for property offenses, 16 percent for sex offenses, 63 percent for drug offenses, 26 percent for alcohol offenses, 9 percent for escape offenses, 18 percent for weapons offenses, 39 percent for public order offenses, 32 percent for motor vehicle offenses, 9 percent for prostitution offenses, and 12 percent for "other" offenses.

Prior Incarcerations. Of the offenders committed in 1991, 44 percent had a history of incarceration for a county sentence; and 11 percent had a history of incarceration for a state or federal sentence. Fifty-four percent were serving their first incarceration as an adult and 46 percent had one or more prior adult incarcerations.

Prior Probations. Of the offenders committed in 1991, 64 percent had a history of one or more prior periods of probation supervision and 36 percent had no probation supervisions prior to the current commitment.

Prior Defaults. Of the offenders committed in 1991, 75 percent had one or more defaults on their criminal record and 25 percent had no defaults on their criminal record.

Age at Entry into Criminal Justice System. Fifty-five percent of those committed had their first court appearance at age 19 or younger. Of these, 33 percent had their first court appearance for an alcohol offense at age 19 or younger and 27 percent had their first court appearance for a drug offense at age 19 or younger.

GLOSSARY

**MINIMUM SENTENCE/
MAXIMUM SENTENCE**

In the tables minimum and maximum sentence lengths are truncated to the closest whole year. For example, a sentence of 5 years 1 day is included in the 5 year category.

OFFENSE

Armed Assault

Includes armed assault with intent to rob, armed assault in dwelling house, assault and battery with dangerous weapon, and assault by means of a dangerous weapon.

Assault-Intent to Murder

Includes assault with intent to murder and attempt to murder.

Assault with Intent to Rape

Includes assault with intent to rape and indecent assault and battery.

Contempt of Court

Includes contempt of court, failure to appear, perjury, violation of a court or restraining order, notation of abuse prevention act.

Rape of Minor

Includes rape of female under sixteen, rape of child, and statutory rape.

Unarmed Assault

Includes unarmed assault with intent to rob, assault, assault and battery, other assaults, and confining or putting a person in fear for the purpose of stealing.

SENTENCE TYPE

Aggregate

Multiple sentences received for more than one offense. These sentences will be served consecutively. The sentence length reported reflects the total of all sentences.

GLOSSARY (Cont.)

Concurrent	Multiple sentences received for more than one offense. These sentences will be served simultaneously.
Fine	Incarceration resulting from non-payment of a fine for one or more offenses.
Forthwith	A sentence that is to be served effective immediately, regardless of other sentences for which the individual is currently incarcerated.
From and After	A sentence to be served following release from a previous sentence.
Simple	One sentence received for a single offense.
Split	A sentence that is divided between a specified period of incarceration followed by probation supervision.
