Abstract

This report presents a statistical description of the 3,084 offenders released to the street from a Massachusetts correctional facility during 1987. This report also presents information on trends among releases over the last five years.

Highlights from this report include the following:

- The 3,084 releases in 1987 represent an increase of 62 (2 percent) over 1986 releases and an increase of 1108 (56 percent) over 1983 releases.
- The number of males released during 1987 increased by 4 percent from 1986, while the number of females released during 1987 decreased by 2 percent.
- Fifty-six percent of all releases were by parole, 35 percent were by discharge and 9 percent were by expiration of sentence.
- Fifty-one percent were released from maximum or medium security facilities and 49 percent were released from lower security facilities. Many of those released from secure facilities were females serving county sentences or male parole violators.
- The average time served was 52.1 months for individuals serving Cedar Junction sentences, 19.2 months for individuals serving Concord sentences, and 6.1 months for individuals serving Framingham sentences.

Introduction

This report is a statistical description of individuals released to the street from facilities of the Massachusetts Department of Correction during 1987. The tables which follow contain information on the nature of the present offense, personal background characteristics, criminal history, furlough program participation and release characteristics for these individuals. The information contained in these tables was derived from the computerized inmate data base and was produced by the Operations Research Unit on the Regent's Computer Network (RCN). Information is also reported on trends in the release population over the last five years, 1983 to 1987.

Only those individuals who were released to the street by the authority of the Parole Board, by expiration of sentence, or by a certificate of discharge are included in the report. Individuals who were released to another correctional authority or to another sentence are not included. Individuals who were released by any means other than parole, discharge or expiration are not included in the report. This includes releases by court order, death and escape. Individuals transferred to other correctional authorities to serve their sentences who were subsequently released are not included in the report; individuals transferred from other authorities who were subsequently released from a DOC facility are included in the report. Individuals who were released more than once during 1987 are counted as multiple cases in the report.

In reading the tables in this report, the reader should note the following: (1) the release population is divided according to the institution of release; (2) the top number in each cell represents the number of individuals who fall in the corresponding category in the table; (3) the bottom number in each cell represents the percentage of the number of individuals in a particular category to the total number of releases from that institution (column percents).

For example, upon referring to the table on page 34, committing institution is presented and the following types of information can be obtained:

- (1) the number of releases from each facility in 1987; and,
- (2) the number and percentage of releases from each institution who were originally committed to each of the committing institutions.

The reader should note that the number in the unknown category is relatively high for certain variables, especially certain social history variables. This is due to incomplete community data records at the initial booking, or at the pretrial intake. Caution should be used in interpreting these variables.

Releases From the DOC, 1983 to 1987

During the last five years the number of releases from the DOC increased from 1,976 in 1983 to 3,084 in 1987. This represents an increase of 56 percent. Table 1 (on pages 8 through 10) shows selected characteristics of releases for each year in this period. The increase occurred for both male and female releases. Male releases increased from 1405 in 1983 to 2319 in 1987 (65 percent). Female releases increased from 571 in 1983 to 765 in 1987 (34 percent).

In 1987, 43 percent of all males were released from maximum or medium security facilities and 57 percent were released from lower security facilities. This is similar to the pattern of releases over the previous five years. In contrast, 76 percent of the females were released from higher security facilities and 24 percent from lower security facilities. This is similar to the pattern of prior years.

Most males released from the DOC during the five year period were serving state prison or reformatory sentences. However, there has been an increase each year in the proportion of males released from the DOC who were serving county sentences. Most females released from the DOC were serving county sentences. There is a small proportion of females who were released on state prison or reformatory sentences. Releases on state prison sentences has increased slightly for females over the five year period, while releases on reformatory sentences decreased slightly from 1983 to 1985 and has remained the same through 1987. The type of sentence that individuals were serving prior to release is shown in Table 1.

Type of release is related to the type of sentence served. Most males are released by parole and most females are released by expiration of sentence. There appears to be a steady increase in males and females released by discharge for each year. The pattern of types of release is shown in Table 1.

The average time served varies by the type of sentence served. For 1987 releases the average time served for a Cedar Junction sentence was 52.1 months, the average time served for a Concord sentence was 19.2 months and the average time served for a Framingham sentence was 6.1 months. From the data presented in Table 1 there appears to be a slight increase in time served for Framingham sentences, from 5.5 months in 1983 to 6.1 months in 1987. For Concord sentences, the time served increased each year for 1983 to 1986, but then decreased for 1987 releases. Time served for Cedar Junction sentences do not exhibit any clear trends, although there has been a decrease in time served for 1987 releases versus 1983 releases.

Overall, during the past five years releases from the Department have increased each year. The percentage increase has been more marked for males than for females.

A Profile of 1987 Releases

Release Characteristics

Tables 2, 3 and 4 (on pages 14 through 16) present selected characteristics of the offender and the release for 1987 releases. All the other tables that follow show the released population by the institution from which the offender was released. In order to maintain the privacy of the individual offenders, no information is presented for institutions from which fewer than five individuals were released. This affects the presentation of the data for three institutions (Old Colony Correctional Center, Lemuel Shattuck Hospital, and Drug Rehabilitation). The three releases from Lemuel Shattuck Hospital are included in the following tables as being released from the institution they were in prior to placement at the hospital (in one case Concord; in another case Norfolk and in the third case Lancaster). The four releases from Old Colony are included in the total column but do not appear elsewhere in the tables, as is the one release from Drug Rehabilitation.

Institution Released From. Table 2 presents information on the specific institution and security level from which individuals were released by the sex of the offender. For male releases, 43 percent were released from maximum or medium security facilities and 57 percent were released from lower security facilities. In contrast, 76 percent of all females were released from maximum or medium security and 24 percent were released from lower security facilities.

Type of Sentence. The second variable examined in Table 2 is type of sentence served for 1987 releases. For females, 86 percent of those released from the DOC during 1987 were serving county sentences which typically are very short. In contrast, 44 percent of the males released from the DOC were serving state prison sentences, and 41 percent were serving reformatory sentences.

Type of Release. For males, the most common type of release was parole, accounting for 64 percent of all releases in 1987. In contrast, 32 percent of the females were paroled. For females, 68 percent of all releases were by expiration of sentence or discharge. In contrast, 36 percent of males were discharged and no males were released by expiration of sentence.

The information presented in Table 2 show that 1569 (51%) of the 3084 releases were from maximum or medium security facilities. A further analysis of releases from these facilities show that 580 (37%) of these releases are females. The large number of females released from higher security facilities is related, in large part, to type of sentence served, i.e., the majority of the females released were serving short county sentences. This explanation does not apply to males, because very few serve county sentences. Table 3 explores select information on the 989 males released during 1987 from maximum or medium security institutions.

Parole Violator Status. For male releases, the security level released from is often related to parole violator status, that is, many of the releases are actually parole violators being re-released on a sentence. Of the 989 releases from secure facilities, 439 (44%) were parole violators, while 549 (56%) were first releases. Parole violators tend to serve a short amount of time from their return until their re-release, which may explain why so many are released from secure facilities.

Split Sentences. Some of the first releases from secure facilities are individuals who received split sentences. A split sentence is divided into a term of incarceration followed by community supervision by the court. There were 108 males with split sentences who were released from secure facilities as first releases. This makes up 20 percent of the 550 individuals who were first releases from secure facilities. Since the time served in prison for persons receiving split sentences is usually short, this hinders transfers to lower security.

Another variable that may explain some of the releases from secure facilities is whether or not the inmate had received lower security placements during his period of incarceration. Past DOC research has shown that the majority of males released from secure facilities had received one or more placements in lower security settings during their incarceration.

Time Served. Table 4 shows time served until first release by committing institution and offense. Time served varies by committing institution (52.1 months for Cedar Junction, 19.2 months for Concord and 6.1 months for Framingham). Time served also varies by offense category. For example, individuals committed to Cedar Junction served longest for person offenses (an average of 66.9 months) and shortest for drug offenses (26.9 months); individuals committed to Concord served longest for person offenses (an average of 21.5 months) and shortest for drug offenses (13.7 months); and individuals committed to Framingham served longest for person offenses (an average of 23.8 months) and shortest for offenses in the "other" category (2.5 months).

1. Individuals who were parole violators, were originally committed to another authority or were serving complex sentences (forthwith, split, fines or from & after sentences) were excluded from the analysis.
2. Offenses were selected based on the frequency with which they appear among the releasee group.

Nature of Present Offense

Sentencing Courts. Originally 65 percent of the releases were sentenced in Superior Courts including 19 percent from Suffolk Superior Court, 11 percent from Worcester Superior Court and 10 percent from Middlesex Superior Court. Twenty-two percent of the releases were sentenced in District or Municipal Courts. Twelve percent were transfers from other jurisdictions (out-of-state, federal or county inmates).

Jail Credits. Fifty-four percent of the releases spent time in jail prior to their commitment; 46 percent had spent no time in jail prior to their commitment.

Commitment Institution. Cedar-Junction commitments represented 33 percent of all releases; Concord commitments represented 30 percent of all releases and Framingham commitments represented 25 percent of all releases. There were 367 (12 percent) individuals released who were originally committed to another jurisdiction (most of which were Longwood releases).

Sentence. Most releases (66 percent) were serving either reformatory or county sentences. Sixteen individuals who were serving life sentences were released in 1987. Fifteen lifers released during 1987 had second-degree life sentences. Fourteen of these individuals had been committed for murder 2 and one for armed robbery. One individual had an out of state life sentence for first-degree murder and was released from a DOC facility during the year.

Present Offense. Forty percent of the releases were serving sentences for violent offenses (33 percent for person offenses and 7 percent for sex offenses), 22 percent were serving sentences for property offenses, 16 percent for drug offenses and 22 percent for "other" offenses. There were four individuals who were serving sentences for murder 1 who were released.

One of these individuals was an out of state inmate and three had received a commutation in their sentence from a term of life to a sentence of years.

Age at Incarceration. The median age at incarceration for the releases during 1987 was 26 years old.

Personal Background Characteristics

Sex. Seventy-five percent of the releases were male and 25 percent were female.

Race. Twenty-five percent of the releases were black and not hispanic and 62 percent were white and not hispanic. There were 7 Native Americans and 5 Asians in the release group. Twelve percent of all individuals released were Hispanic.

Marital Status. The majority of releases (64 percent) were single at the time of their commitment.

Military Discharge. Of the 2977 releases for whom military information was known, 88 percent had never served in the military.

Prior Address. The largest group of releases (46 percent) came from the Boston MSA.

Occupation. Most releases whose occupations were known had worked in the areas of manual labor (50 percent) or services (27 percent) prior to commitment.

Education. The median educational level for the 1987 releases was eleventh grade; 48 percent had achieved at least a high school level of education.

Criminal History

The rate of unknowns for the Criminal History variables is 10 percent, the percentages below are based on those cases where criminal history information is known.

Prior Court Appearances. The median age at first court appearance was seventeen years. The median number of court appearances prior to their current commitment was 9. A majority of the releases had previously appeared in court for person offenses (69 percent) and property offenses (78 percent). A minority had appeared in court for sex offenses (14 percent), alcohol offenses (32 percent) and escapes (8 percent). Slightly more than half of the releases had court appearances for drug offenses (51 percent).

Prior Incarcerations. Sixteen percent of the releases during 1987 had prior juvenile commitments, forty percent of the releases during 1987 had prior incarcerations in a house of correction and 16 percent had prior incarcerations in a state or federal correctional institution. Overall, 47 percent of the releasees had served some time in an adult correctional facility for another commitment.

Prior Paroles. Five percent had been paroled while a juvenile and 54 percent of those had received a parole violation while a juvenile. Twelve percent of the releases during 1987 had been paroled as an adult and 66 percent of those had previous parole violations. Overall, 14 percent had been paroled at least once prior to their current release and 67 percent of those had previous parole violations.

Furlough Program Participation

Twenty-two percent of the releases had one or more furloughs during their present incarceration; 78 percent had no participation in the furlough program. Thirteen individuals had one or more furlough escapes. Five percent of the 1987 female releasees and 27 percent of the male releasees had one or more furloughs during their present incarceration. This difference is due, in large measure, to the fact that such a large number of females receive relatively short county sentences.
