


RE: IN SUPPORT OF PETITION BEFORE THE DTC

The following names are that of prisoners of Massachusetts Department of Corrections that are directly affected by the poor quality of the prison telephone service provided by Global Tel Link consisting of but not limited to : dropped calls to which when we call back we have to pay another connection fee, the cost of a twenty minute phonecall is robbery due to it being the 21st century and technology is far advanced where free persons can pay twenty five dollars a month for unlimited minutes along with many other services, a recording comes on in the beginning of a phonecall letting the recipient of the call to know that it's an institutional call there is no need for a prompt every few minutes which disrupts the conversation and extracts from the time that we are charged for.

For a majority of us our families live to far for visits and the telephone is the only way for immediate contact with our loved ones. Keeping in touch with our families is the most important thing to us second only to positive rehabilitation which coincides with one another. Instead of being a bridge the telephone servicer has become a barrier to us and a burden on our families.

We are in concert with Prisoners' Legal Services in support of the petition filed on behalf of us, other prisoners, families, attorneys, and other users of prison telephone service.
